



## Regulation "Take Care Wristband" 2022

LEGOLAND® Deutschland offers a Take Care Wristband to all severely walking disabled or mentally disabled guests. It serves the purpose to ease the access to our attractions and shorten possible waiting times\* for persons with severe disabilities.

A condition to receive the Take Care Wristband is a disabled person's pass with a H, aG or G note in combination with a B note. Additionally, **every** disabled person needs a liable person (at least 18 years old). This person must sign the overleaf declaration. In order to save time at site, you can fill out the declaration in advance.

The liable person is responsible that the disabled person can access and exit the attractions quickly. This also includes the quick entering and exiting the vehicle and the quick exiting of the attraction/ride in case of an emergency. The liable person is responsible for the safe behaviour of the disabled person during the ride.

The Take Care Wristband for the disabled person and the liable person can be obtained at the information desk in the Entrance Area.

The wristbands are to be shown unrequested at the attraction. The liable accompanying person must be able to take a seat directly next to the disabled person. A maximum of two additional people are allowed to enter the ride at the same time.

Please contact the employee after arrival at the attraction and follow the instructions of the operator. The employee at the concerning attraction has the right to deny the entrance to the attraction, if the operator is of the opinion that the attraction is not suitable, and you pose a risk to you or other guests or employees. This serves solely your safety.

All guests must obey the minimum requirements of the concerning attraction which are given by the manufacturer of the ride and the German technical inspection association (TÜV). The minimum requirements can be found in our orientation brochures (available at [www.LEGOLAND.de/orientation-guide](http://www.LEGOLAND.de/orientation-guide) or in the Entrance Area) and on the safety signs at every attraction.

Please note: In case of technical interruption it may be the case that you will have to stay in the gondola / vehicle for a longer period.

The Take Care Wristband may only be used per attraction once an hour.

\*The Take Care Wristband is not accepted in the following attractions: Hyundai LEGOLAND Driving School (26), LEGO® Factory (29), LEGOLAND ATLANTIS by SEA LIFE® (100), LEGO Academy (108), the Nintendo Zone (107) and Rebuild the World - Planet LEGOLAND (106).
